AGREEMENT FOR RENEWAL

Agreement between D.A.V. College Trust and Management Society,  
Chitra Gupta Road, New Delhi - 110 055 and Gujarat Sidhee Cement  
Limited, Sidhee gram, Taluka : Sutrapada, Gujarat - 362 276

This agreement made this First day of April month 2019 between the  
D.A.V. College Trust and Management Society registered under the  
Companies Registration Act 1860, and having its registered Office at New Delhi,  
hereinafter referred to as the "Society" (which expression unless excluded,  
it is relevant to the context shall include its successors and assignee) of  
the one part, and Gujarat Sidhee Cement Limited, a Private Sector  
Enterprise called as Enterprise (which expression unless excluded or is  
relevant to the context shall include its successors and assignee) of the  
other part

Whereas the Enterprise had entered into an agreement with the Government of India (D.O. No. 01-04-1989 for establishing a composite co-educational English Medium School, affiliated to CBSE in the area of its township at Sidheegram providing educational facilities for the wards and dependents of its employees and nearby areas.

And whereas the initial term of the earlier agreement was upto 31.03.1999 and thereafter it was extended from time to time upto 31.03.2019 (from 01.04.1999 to 31.03.2009 and 01.04.2009 to 31.03.2019) as per the terms & conditions contained in the initial Agreement dated 01.04.1989.

Since the Enterprise is satisfied with the functioning of the said school and on completion of the term of the agreement upto 31<sup>st</sup> March, 2019, the parties have further mutually agreed to extend the Agreement for a period of 10 years commencing from 1<sup>st</sup> April, 2019 to 31<sup>st</sup> March, 2029.

However, there are few clauses mentioned hereunder are to be incorporated with the initial agreement entered between both the above parties.

1. That the Enterprise shall ensure that the share of the management to Gratuity, Leave Encashment and other benefits are to be kept in the school account.
2. That the school shall continue to function in its existing complex subject to the condition that it is meeting the requirement of CBSE of granting affiliation to the school.
3. That the school shall pay to the DAV College Management Committee each month 5% of the (Basic + D.A.) of the school staff to cover its administrative charges.
